President Podbielniak called for a motion to accept the minutes from August 22, 2017. Amendment to minutes in regards to garbage rates in the Village. The rate will remain the same for the next five years. Trustee Casillas moved, seconded by Trustee Lopez. All Trustees Voted Aye; motion passed, minutes were approved.

Chicago Police Department rented our Community Center, for \$1,000.00 last Tuesday, September 5th. They were filming a movie in Dixmoor and used our facility to serve breakfast, lunch and dinner to the actors and crew, that participated in the movie.

Has there been much participation in the children's after school program? The fee for the program is \$40.00 per week. There will be tutors from Bremen High School, both students and some teachers. Also, there will be a computer room set up for the kids to use.

What is Fitness Camp? It is a workout class.

The Village is looking for volunteers to help with cleaning on the medians on 147^{th} Street, the weekend of September 23^{rd} and 24^{th} .

Congressmen Rushes office is working with Posen to try and get the Flood Plain designation removed from the East side of the Village. Due to the huricanes, FEMA is very busy right now and will get back to us when things slow down a little.
