# 15% Additional Incentive

For a limited time, private and public sector customers located in select communities will receive a **15% additional incentive** on their energy efficiency project!

When your small business or public facility shines, so does your community. With a 15% additional project incentive from the Small Business offering, saving on energy costs and improving your facility's energy efficiency has never been more attainable!

Investing in energy efficiency can improve the safety and comfort inside your facility. Plus, with the additional 15% incentive, you'll see a quicker return on your investment. Don't wait, start your project today!

## Eligibility

- Submit a new Small Business offering pre-application between January 2, 2024, and March 31, 2024, or before promotional funds are fully reserved, with a final application and invoice submitted by May 31, 2024.
- Must be a customer with an electrical peak demand under 400 kW to be eligible for the additional incentive. Customers with electrical peak demand over 400kW are eligible for our Standard offering additional incentive.
- Eligibility for this additional incentive is determined at the city level, except for the City of Chicago where eligibility is determined by ZIP code. Please see below for eligible cities and zip codes.
- This 15% additional incentive is capped at \$10,000 per customer account.

 Until promotional funds are fully reserved, public customers can combine this additional 15% incentive with the Small Business Public Sector 15% additional incentive for a total of 30% in additional incentives and a combined cap of \$20,000 per ComEd customer account.

# How to Participate

- Schedule a FREE energy assessment with an authorized Small Business Energy Efficiency Service Provider.
- Your Service Provider will submit your new pre-application.
- After your project is approved and funds reserved, your Service Provider will install the equipment and complete your project.
- Your Service Provider will submit your final application and invoice.
- The additional incentive payment will be applied after your project is completed.
